



## 2011-2012 GUARDIAN ANGELS TUITION PAYMENT POLICY

### **REGISTRATION FEE:**

The Registration fee for 2011-2012 is \$175.00. An early registration fee of **\$150 per family can be paid to Guardian Angels on or before February 14, 2011**. Registration fee must be included with the completed registration and billing forms. Please pay any PTA and booster fees at this time. Registration will not be considered complete without payment.

### **MULTIPLE STUDENT DISCOUNT (for Active Parishioners\*):**

### **PAYMENT PLANS:**

**Plan A:** Total tuition payment is due in full on or before June 3, 2011. Payment may be paid by check to “Guardian Angels School” or by credit card (with corresponding credit card fees of approximately 2.5% added to your balance).

**Plan B:** Half of the tuition payment is due on or before June 3, 2011, with the remainder paid in equal installments over six months from July – December, 2011. A payment fee of \$60 will be added to the total tuition amount. Initial June payment may be paid by check to “Guardian Angels School” or by credit card (with corresponding credit card fees of approximately 2.5% added to your balance). Installment payments from July – December must be made by Electronic Funds Transfer (“EFT”).

**Plan C:** Total tuition is paid in equal installments over 10 months, from March – December, 2011. A payment fee of \$90 will be added to the total tuition amount. Installment payments must be made by Electronic Funds Transfer (“EFT”).

### **Electronic Funds Transfer (EFT):**

For Plans B and C, please include EFT (bank account) information on the Registration Form. Note that a \$25.00 fee will be added to your balance for any “insufficient funds” that may occur in processing your payments.

### **TUITION AID:**

Families who are registered, active parishioners may apply for tuition aid. The Private School Aid Service and a confidential committee provide tuition aid on the basis of need as determined. **Tuition aid is not available for Kindergarten tuition.** A link to the online PSAS application is available on the GA web site. Forms are also available through the school office. **All tuition aid information is held in the strictest of confidence.**

### **EXCLUSION OF STUDENT FOR UNPAID ACCOUNT:**

- Registration for the 2011-2012 school year will not be accepted if there is an outstanding tuition balance.
- No child will be admitted to the school on the first day of a trimester if accounts are not up to date.
- Unless arrangements have been made with the Tuition Office, first payment or payment in full is due on or before June 3, 2011. A \$100 late fee will be assessed.
- Registration will not be accepted without registration fee.

### **\*ACTIVE PARISHIONER POLICY:**

- Active Membership is determined by four things:
  1. Faithful attendance at Mass at Guardian Angels on Sundays and holy days.
  2. Being registered as a parishioner at Guardian Angels.
  3. Volunteer activity in the parish.
  4. Use of the envelope system or electronic fund transfer for financial support of the parish.
